By signing this contract, and at the completion of the 14 day trial period, you are agreeing to the following:

1. You are 18 years or older and have read, understood and agreed to the terms below.
2. You have inspected the dog and agree to accept the pet in its current condition, health and behaviour. You have not relied on any representation by Iron Dog rescue in deciding to adopt the pet.
3. The adoption fee of \$ _____ is payable to Sue Ebert, Iron Dog Rescue and is a contribution to the work of Iron Dog Rescue in rescuing, rehabilitating and rehoming of dogs and is not refundable after the trial period of 14 days.
4. The trial period of 14 days commences immediately on signing this agreement.
5. You agree to contact Iron Dog Rescue immediately should any problems arise during the 14-day trial period, this includes the pet becoming lost or if you have any health or behavioural concerns.
6. You must take the Change of Ownership form to your local Council or register your pet online with www.petregistry.nsw.gov.au immediately after the trial period of 14 days and pay the cost of registration determined by your Local Council. You will be responsible for

any cost or charges incurred should be pet be impounded during or after the trial period of 14 days.

7. If the dog is housed with other dogs, small animals, cats, poultry, livestock or children and adults, you agree to supervise the dog at all times, and take all reasonable steps to prevent injury to any animal or person which could be incurred by the dog.
8. The dog must be returned to Iron Dog Rescue if the dog is deemed unsuitable during the trial period. The adoption fee paid will be fully refundable unless the dog has suffered from mistreatment, preventable injury or disease during the trial period. Should, on veterinary advice, it be found that the dog has suffered from mistreatment, preventable injury or disease refund of the adoption fee will not apply.
9. If, at a later date, you are unable or unwilling to continue to care for this dog at any time during the lifetime of the dog, you agree to contact Iron Dog Rescue and give them the option to reclaim the dog at no charge.
10. You will care for the dog in a humane, responsible manner and continue to provide it with clean and adequate shelter, food, water and veterinary care as required at all times for the life time of the dog.
11. Iron Dog Rescue give no guarantee or warranty, expressed or implied, that the dog being adopted is of suitable temperament.
12. You indemnify Sue Ebert and Iron Dog Rescue for any liability, costs or expenses which arise as a result of your actions or omissions (including negligence) or the pet's condition, health or behaviour whether during or after the 14 day trial period.
